He will take necessary steps for discharge of the duties of Anti-Ragging Committee as per National Medical Commission (Prevention and Prohibition of Ragging in Medical Colleges and Institutions) Regulations, 2021 and the SOP issued by the University. The Anti-Ragging Committee will submit its report to University Monitoring Committee.
