ELIGIBILITY CRITERIA FOR ADMISSION IN GNM

- Candidate must qualify entrance exam (CPNET) conducted by UPUMS Saifai and candidate selected on merit base
- The minimum age for admission shall be 17 years on 31st December of the year in which admission is sought
- Candidates must pass 10+2 with english and must have obtained minimum of 40% at the
 qualifying examination and english individually from any recognised board. Candidate are also
 eligible from state open school recognised by state government and National Institute of Ope
 School recognised by Central Gvoernment.

Or

• 10+2 with english having 40% marks in vocational stream- Health Care Science from a recognised CBSE Board (In 10+2 certificate/marksheet vocational stream- Health Care Science must be mentioned).

Or

- Registered ANM with pass marks (There is no age bar for ANM and LHV)
- 5% is relaxed for SC/ST candidates.
- The selection of candidates will be subject to medical fitness. No selected candidate will be permitted to join the course unless declared medically fit.
- Reservation for disability (PwD): 5% Horizontal reservation will be considered for disabled candidates with a disability of loco-motor to the tune of 40% to 50% of the lower extremity and other eligibility criteria with regard to qualification will be same as prescribed for Unreserved (UR) category candidates. (The Gazette of India No. 275 dated 05th July 2021).
- For admission, the candidate must be a domicile of Uttar Pradesh (Candidate is having the Domicile certificate of Uttar Pradesh issued from a competent authority OR candidate has passed 10th and 12th intermediate (10+2) BOTH board Examinations from Uttar Pradesh).
- Reservation for Minority and any other Category will be as per Government of UP norms/ directives.
