The Board of Governors also decided to recommend to the Central Government that renewal of recognition of MD(Biochemistry) qualification for 1 seat granted by C.S.J.M. University, Kanpur in respect of students being trained at U.P. Rural Institute of Medical Sciences & Research, Etawah be renewed.

The Board of Governors further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course "
